We are committed to being a good neighbor by providing frequent and transparent information and protecting the health, safety, and environment of the communities we live and work in. Part of that commitment includes the Stakeholder Relations team as a dedicated resource to you now and throughout this process. We will be working with you directly to share details about the proposed project, provide updates on progress and timing, and are available to speak with you through our Response Line phone line, email address, and website as well as in-person meetings upon request.

There are many rules and regulations that Oxy must meet and adhere to not only during operating but prior to beginning this proposed temporary project. These rules and regulations from both state and local agencies have varying requirements. For this reason, you may receive information in the coming weeks related to a spacing unit application, regulatory hearings, or other notices of permitting processes. If you receive these mailings and have any questions at all, please reach out to us. We welcome your questions and feedback.

Because we value your feedback, we would like to share the steps we are taking related to input we have received from your community. We understand that communication, protecting your water wells, and minimizing any temporary impacts are top priorities for you. We will be hosting a community meeting to provide another avenue for sharing our proposed plans for the project, to share our robust process for monitoring well integrity, and what that means for your community. Information about the community meeting will be shared in a future mailing.

# Pathway to Low Carbon Energy

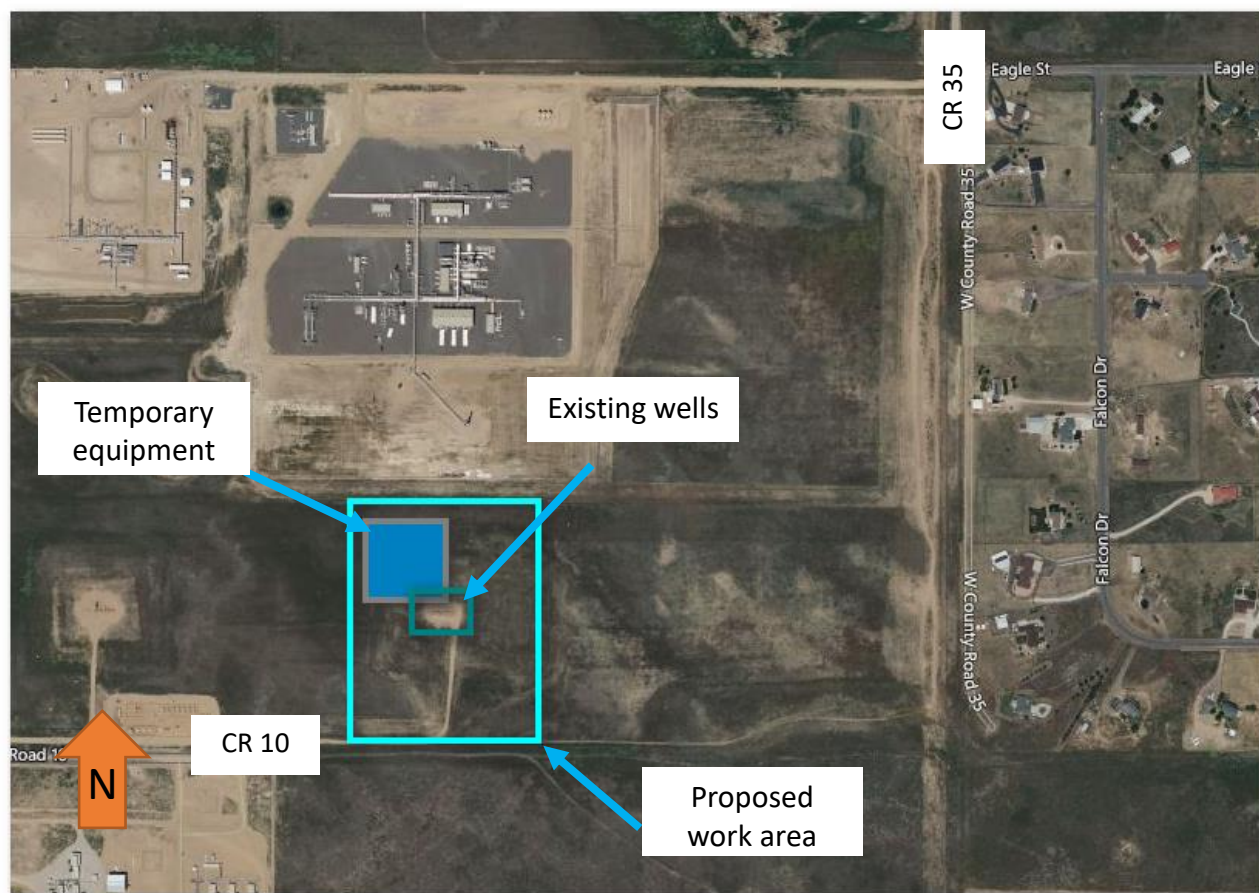
Oxy is working through the permitting process on a project to produce low-carbon energy from existing oil and gas wells. We are using our industry-leading expertise in carbon management to reach our Net Zero emissions goals. The Colorado Energy and Carbon Management Commission (CECMC) and Weld County both require permits and approvals for this project. We are committed to being a good neighbor by providing frequent and transparent information and seeking your feedback.

This project utilizes temporary equipment and previously produced gas to displace trapped oil and gas in existing oil and gas reservoirs. Activity for the proposed work, which will include the use of a workover rig, is scheduled to begin in 2023 and be completed around the summer of 2026. Additionally, all equipment will be placed to the west of the existing well pad.

Below is an overview of the estimated timeline and map of the proposed location.

# Our Commitment To You

## Ground Water Protection



- Oxy has collected extensive data on water wells in northern Colorado. Samples, collected by third-party scientists and sent to independent laboratories, have been analyzed and shared with the CECMC.
- Oxy has committed to continuing third party water well sampling and testing before, during, and after the project is complete.

## Equipment



- Temporary compressor will be fully enclosed
- Temporary compressor and other equipment will be powered by electric motor
- All equipment to be placed on west side of the existing well pad

## Traffic



- Oxy will access the location through County Road 10
- The construction phase will account for the most concentrated volume of truck trips and will average less than 20 trips per day

## Noise



- Oxy strictly follows all state and local rules and regulations
- A third-party sound study shows that this project will remain within the allowable noise requirements
- Electric motor and compressor will be housed inside a fully enclosed, sound weakening building
- Continuous air monitoring
